**8:30 AM - Welcome and Approval of Minutes**

**8:40 AM - Climate Corps Announcement**

- The grant for Climate Corps was initially written for a hybrid program, but the grantors requested it be an in-person program.
- Partnership established with Bennington and Vermont Institute (VI) Woman in Agriculture.
- Housing arrangements need to be made for the Climate Corps members, who will receive a small stipend.
- Workforce development members from the VI will arrive on September 19th.

**9:00 AM - Tree Sale Debrief**

- 1,050 trees sold, including chestnut, yellowbud hickory, shellbark hickory, shagbark hickory, hazel, black walnut, honey locust, persimmon, and bur oak.
- Approximately 3,000 chestnut trees remain, donated by Yellowbud Farm.
- There are plans to plant the remaining trees at Niko's, coupled with a soil health workshop on May 31st. There will also be an additional planting event at Willie's on June 1st.
- Discussed the Hickory Mapping Project, Harvest Lease, and oil press initiatives.
- Discussed the need to meet and plan for next year's tree sale so it runs more smoothly.
- A recommendation was made to use tags.

**9:10 AM - VACD Meeting on May 16th**

- Capacity Building Survey results and reflections.
- Governance Committee updates
  - Tensions with Action Circle accusing the District of undermining lobbying efforts.
  - The upcoming retirement of Jill and potential restructuring.
  - Concerns over the role and effectiveness of VACD as the lobbying group.
  - Discussion on funding allocation: WRNRCD's funding issues and the distribution of funds.
  - There is a need for greater transparency and accountability from VACD.
  - Emphasis on the need for self-governance and setting a good example for other districts.
  - The board decided to draft several letters addressing governance and funding concerns with VACD.
- 30x30
  - Discussed the 30x30 initiative and Jennifer's testimony. 30x30 has not been discussed as a board. The board needs to clarify its stance.
