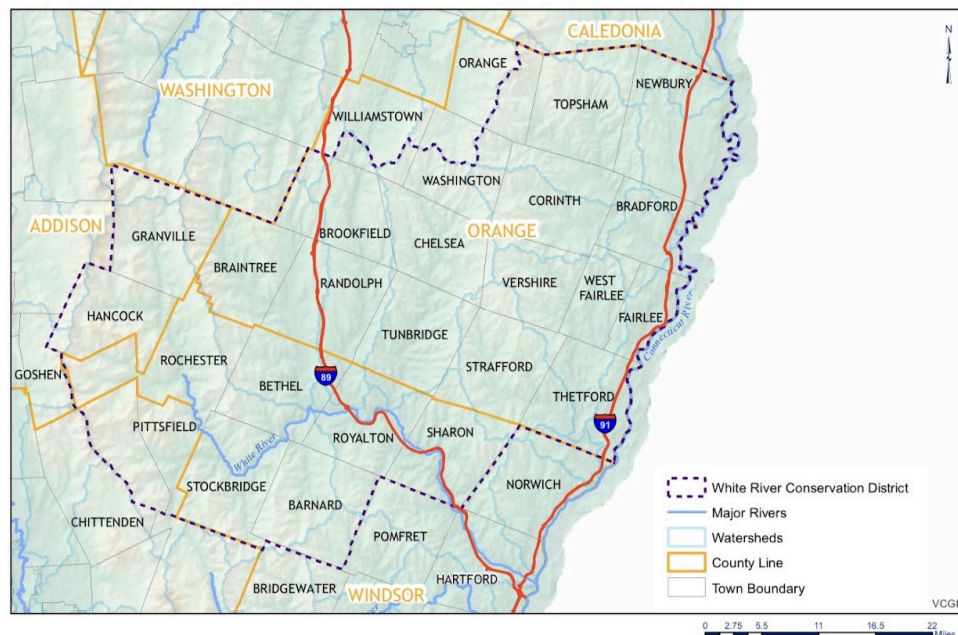
To all those residing within the boundaries of the White River NRCD, notice is hereby given that on January 23, 2024, petitions for the position of Supervisor for the White River Natural Resources Conservation District (NRCD) became available. An election will be held on February 23, 2024 for one Supervisor of the District. Petitions must be completed and returned to the local Conservation District office (whiterivernrcd@gmail.com or 28 Farmvu Drive, White River Junction, VT 05001) by close of business on February 9, 2024.

Candidates for the position of Supervisor must be residents of the District. Only persons who hold title-in-fee land and reside within the District are eligible to sign a petition or vote. You do not have to own land to serve as a Supervisor. Supervisors are elected for 5 year terms, and may not be employees of the federal government.

Conservation Districts are local subdivisions of state government established under the Soil Conservation Act of Vermont. District Supervisors meet monthly and are paid at a per diem rate of \$150 per meeting.
